	Item 7.2; Jane had discussed with Chair whether the induction pack was needed. Although it was noted this item is not urgent, and is not being scrutinised by UK Sport; Chair asked Jane to progress with the draft. Jane continues to lead on this item.
	Item 8.1; Stephen had circulated the letter 22/08/2017 stating that the existing Service Level Agreement between the GB Board and BE has been "suspended".
4	PERFORMANCE UPDATE
4.1	Performance Report

The following points were noted:

- Jon reflected on the World Championships. In the Tokyo submission paperwork submitted to UK sport in Autumn 2016, the target was 1 quarter final to 1 medal. GB actually achieved 1 medal plus 1 quarter final so exceeding the target. The intention is to submit to the Investment Panel meeting to be held on 28th November 2017 for the Olympic Programme, subject to confirmation of the process to be undertaken. Jon is in dialogue with Chelsea Warr, the Director of Performance, and other members of her team regarding our potential submission. UK Sport (Sport Intelligence Unit) are currently carrying out an analysis of our sport to see if Badminton is now a Band 3 sport. It is not certain if the Investment Panel meeting held on 28th November 2017 will be attended by representatives of GB/Badminton England (BE) but this will be confirmed in the coming days. The Investment Panel will make recommendations to UK Sport Board in December and will confirm the outcomes to NGBs in the first week of January. Should UK Sport choose to fund it would not commence until 1 April 2018.
- Paralympic programme will undertake the same process as Olympic subject to confirmation that we meet the Band 3 requirement to have players "very likely" to medal. Further detail in point 6 of the agenda.
- An update of the Solidarity Awards was received. The BOA assess applicants against their criteria and they have 12 Solidarity Awards to give out.
- Jon is attending a recce in preparation for the Tokyo Olympic Games between the 14-19 October 2017. This will be paid for by the remnants of the transition funding from UK Sport. This visit will focus on accommodation as the Olympic Village is about 50-60 minutes away from the venue. There are two further recce's before Tokyo which will be funded by BOA.
- Mark reported that due to B E's new financial administration system, the financial report on the allocation of UK Sport funding promised in June, for which the GB board is accountable, is still not produced but he said it would be received by the Board within 8 weeks.
 - He confirmed the transition figures between April and July accumulated to £89,075 and with an agreed underspend (16/17) of £20,000 which could be carried forward, the budget of £108,000 had been fully allocated.
 - It was agreed with UK Sport that the underspend figure of £20,000 would be allocated to Sport Science and Sport Medicine / lifestyle management etc. whilst the remaining £89,075 would focus on the development of coaches, transition and leadership / management.

Once the financial report has been approved by the GB Board, it will be sent to UK Sport.

6.1 Christine gave a verbal update;

 The classes, disciplines and athlete numbers for the Tokyo Paralympic Games have been confirmed by the IPC

As previously stated, the application will be submitted by November 2017 however it is not known whether we will be successful until January and funding would not commence until April 2018. Adrian stated that the qualifying period is likely to mirror the Olympic qualifying period and commence from 01/05/19.

- BPA has requested the appointment of a nominated Team Leader for Para Badminton for Tokyo 2020, who would be expected to attend the 2018 and 2020 recces, some team building and training activities and the Games themselves. The Chair said he had identified and spoken too, two strong candidates.
- Chair will continue to speak to Michelle Hammond (UKS) on any funding support towards medal potential and development of a funding application. JA is also in communication with UK Sport about this and the two are coordinating their approaches.

GB REPRESENTED TEAMS

7.1 Youth Olympics

- Jon confirmed BOA will fund 2 athletes plus 1 coach to go to the Youth Olympic Games. Funding includes everything that involves them attending.
- Qualification guidelines have been published and the qualification period will conclude on 1 May 2018.
- Formal selection process to take place between 10 and 31 May 2018.
- Jon proposes to select athletes based on the BWF's published qualification process which confirms that GB are likely to qualify 1 male and 1 female player based on their World Junior Ranking at the conclusion of qualification.
- Selection Policy needs to be advertised on all Home Nation websites as soon as possible. Jon and Chair to discuss and send round suggested selection criteria ASAP. Appeal process will be included.
- Adrian asked once criteria is published, the Coaches inform the athletes so they are aware of the process
- Jon stated the Coach should be selected based on the players that qualify but a process should be put in place for GB to select
